## Volunteer Release and Waiver of Liability Form

**1. Waiver and Release:** I, the Volunteer, release and forever discharge and hold harmless Sleepydog Kennel and its assigns from any and all liability, claims, and demands of whatever nature, either in law or in equity, which arise or may hereafter arise from the services I provide to Sleepydog Kennel. I understand and acknowledge that this Release discharges Sleepydog Kennel from any liability or claim that I may have against Sleepydog Kennel with respect to bodily injury, personal injury, illness, death, or property damage that may result from the services I provide to Sleepydog Kennel or occurring while I am providing volunteer services.

**2. Insurance:** Further I understand that Sleepydog Kennel does not assume any responsibility for or obligation to provide me with financial or other assistance, including but not limited to medical, health, or disability benefits or insurance. I expressly waive any such claim for compensation or liability on the part of Sleepydog Kennel beyond what may be offered freely by Sleepydog Kennel in the event of injury or medical expenses incurred by me.

**3. Medical Treatment:** I hereby Release and forever discharge Sleepydog Kennel from any claim whatsoever which arises or may hereafter arise on account of any first-aid treatment or other medical services rendered in connection with an emergency during my tenure as a volunteer with Sleepydog Kennel.

**4. Assumption of Risk:** I understand that the services I provide to Sleepydog Kennel may include activities that may be hazardous to me including, but not limited to an increased risk of dog-related injuries, such as bites and scratches. As a volunteer, I hereby expressly assume risk of injury or harm from these activities and Release Sleepydog Kennel from all liability.

**5. Photographic Release:** I grant and convey to Sleepydog Kennel all right, title, and interests in any and all photographs, images, video, or audio recordings of me or my likeness or voice made by Sleepydog Kennel in connection with my providing volunteer services to Sleepydog Kennel.

**6. Other:** As a volunteer, I expressly agree that this Release is intended to be as broad and inclusive as permitted by the laws of the State of Vermont and that this Release shall be governed by and interpreted in accordance with the laws of the State of Vermont. I agree that in the event that any clause or provision of this Release is deemed invalid, the enforceability of the remaining provisions of this Release shall not be affected.
